New Chattanooga Police reporting policy

WHAT TO DO IF YOU HAVE BEEN INVOLVED IN A TRAFFIC CRASH

If your vehicle and other vehicles involved are movable and there are no injuries caused by the accident, please follow these steps:

1. Call dispatch (423-698-2525).
2. Dispatch will send you to a direct line with instructions on how to report the incident to the state.



3. Collect information from all drivers involved
 - o License
 - o Insurance
4. Take pictures of any damages
 - o Detailed pictures of any dents, marks, or glass breaks.
5. Please remember to be courteous and polite when exchanging information.



WHY IS CPD CHANGING THE POLICY FOR RESPONDING TO TRAFFIC CRASHES?

The reason for the change is the amount of time our officers spend on traffic crashes. Chattanooga Police officers will always respond to crashes involving:

1. Death or injury
2. Hit & run
3. Impairment of an operator due to alcohol or drugs
4. Government-owned vehicles or property
5. Hazardous materials
6. Disturbances between principals
7. Major traffic congestion as a result of the crash
8. Damage to vehicles to the extent that towing is required.

This change will allow our officers to be more proactive and better prepared to react to violence in the city.
