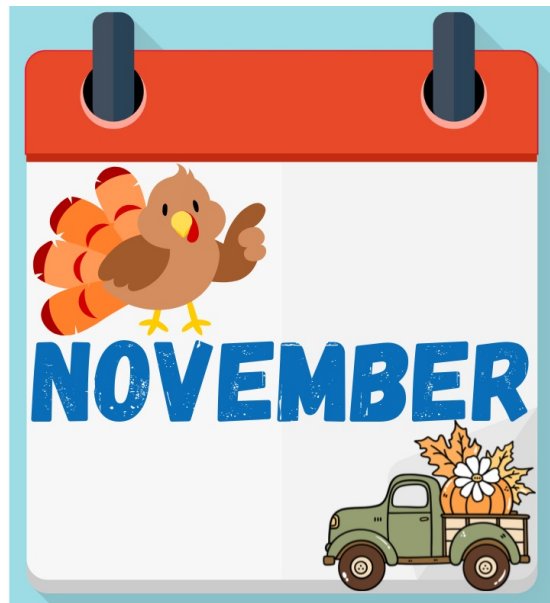

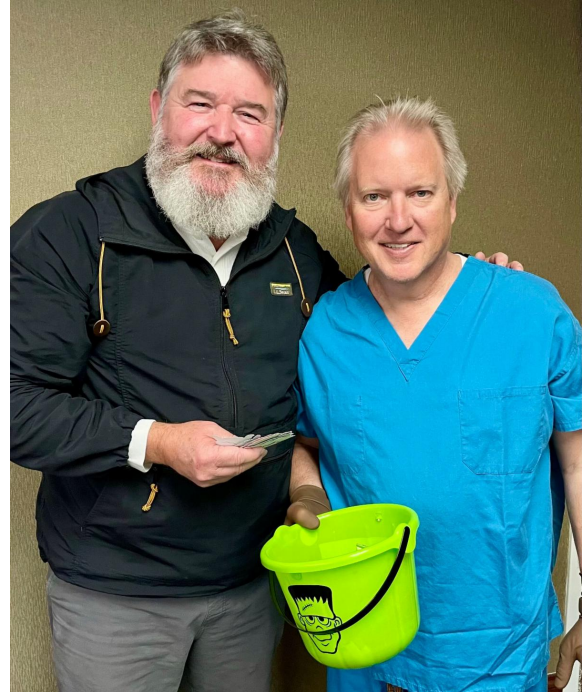

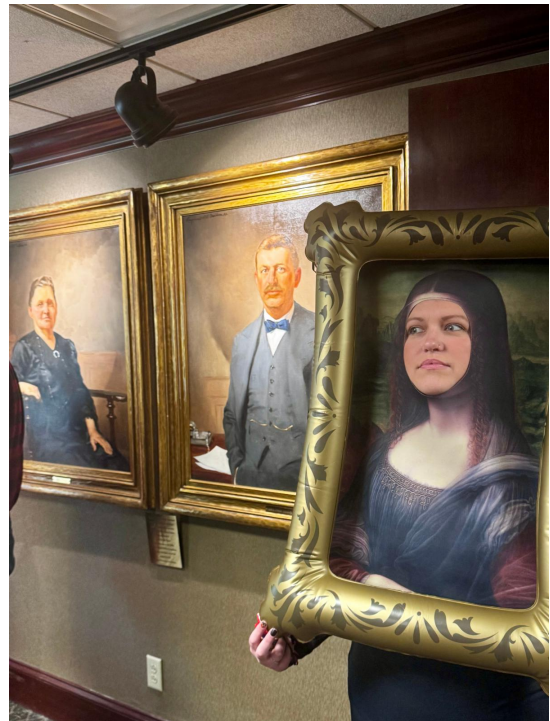


Halloween Block Party + Trick or Treat at Siskin Children's Institute

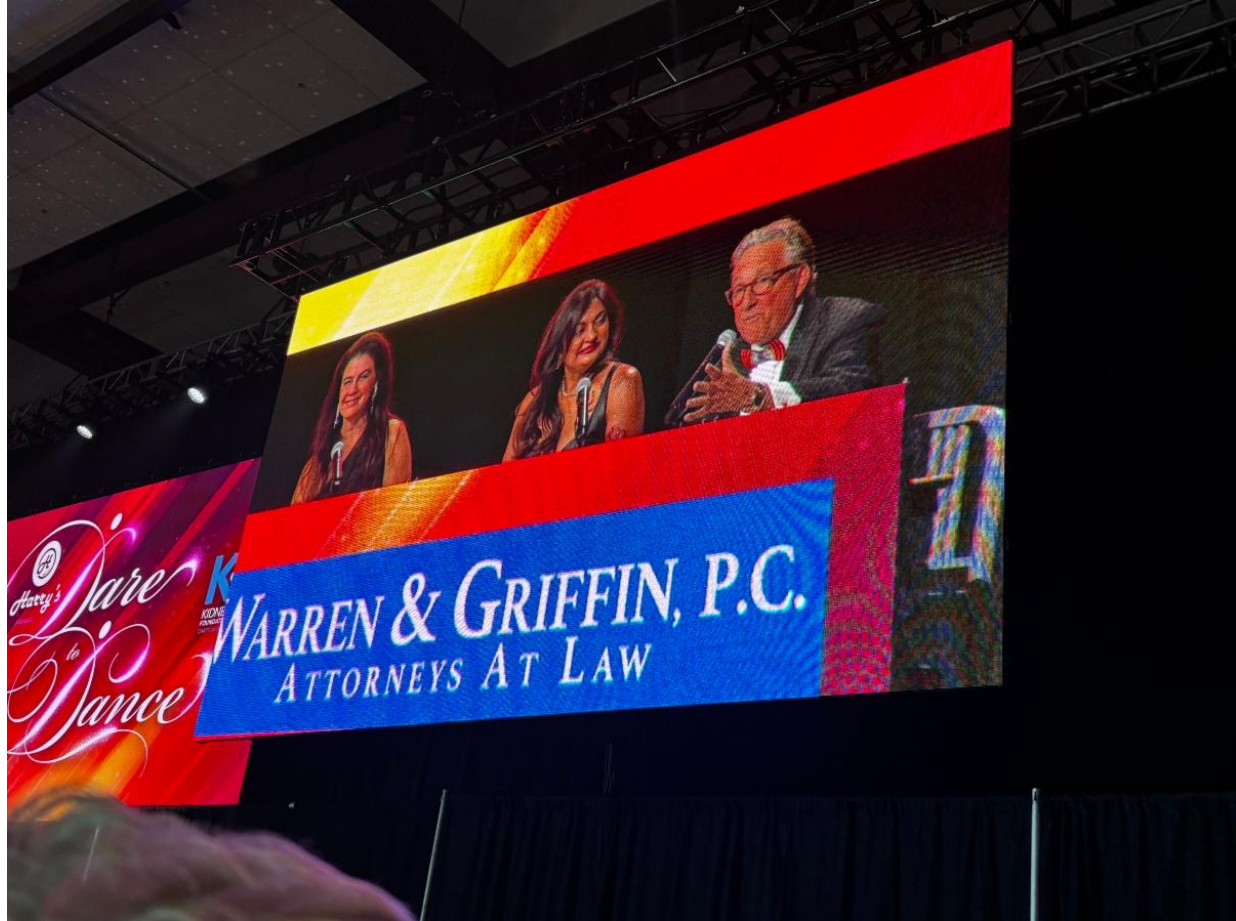
